### Terms of Data Collection -

#### **Consent - The information we collect**

When you request an estimated offer or information regarding our property services, we need to know your name, email address and telephone number. We also need details of the property concerned. We gather this information to allow us to deal with your enquiry effectively and to process any subsequent offer and purchase. The relevant information is then used by **National Property Renters – (NPR)** to provide our services and to communicate with you on any matter relating to the provision of services and in general.

Personal data, or personal information means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data). We may collect, use, store and transfer different kinds of personal data about you which we have grouped as follows:

- **Identity Data:** Includes first name, maiden name, last name or similar identifier, marital status, title, date of birth and gender.
- **Contact Data:** Include postal address, email address and telephone numbers.
- **Profile Data:** Includes orders made by you, your interests, preferences and, feedback and survey responses.
- **Technical Data:** Includes **National Property Renters (NPR)** client ID, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform and other technology on the devices you use to access this website.
- **Usage Data:** Includes information about how you use our website. We also collect and use Aggregated Data such as statistical or demographic data for any purpose. Aggregated data may be derived from your detailed data supplied but is not considered personal data in law as this data does not directly or indirectly reveal your identity. For example, we may aggregate your usage data to calculate the percentage of users accessing a specific website feature that we offer.

## If you fail to provide personal data

Where we need to collect personal data by law, or under the terms of a contract we have with you and you fail to provide that data when requested, we will not be able to progress with our services.

# How we use your personal detailed data

For us to be able to provide our services, it may be necessary to share a limited amount of your personal contact information with third parties, such as but not limited to solicitors, service providers etc. This information

is shared solely for you to progress with the service you have requested & purchased.

We will never pass your details on to an irrelevant third party. The data you provide to **National Property Renters – (NPR)** will only be used to facilitate your sale/purchase offer and/or to provide you with information and special offers around our services.

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we are required to perform the contract details, depending on who is about to enter into or has entered into with you.
- Where it is necessary for our legitimate interests, and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal or regulatory obligation, such as money laundering searches.

## <u>Data Retention - How long we keep your data</u>

**National Property Renters – (NPR)** will retain all personal data for as long as the individual is a customer of the company plus 6 years. This is subject to any overriding legal or regulatory requirements or changes in the law in the future.

Any individual does, of course, have the right to be forgotten. If you would like your personal data to be removed from **National Property Renters – (NPR)** system, you can do so by making a written request to our data officer at:

<u>Data Subject Right – Your rights to access personal information</u>
